Limits on motor sizes are 250hp for inboard/outboard motors, 290hp for inboard motors and 225hp for outboard motors. all boats are limited to 20 feet with the exception of pontoon boats, which must be 28 feet or less. Limit of 2 hulled motorcrafted, no more than one of which shall be a personal watercraft, one pontoon boat and one sailboat over 12 feet allowed to registered per lot. All boats must be registered and owned in the name of the property owner.
